
Zelis Payments ERA 835

Note: We have been notified by Zelis that they have updated their ERA enrollment requirements and will not allow ERA enrollment without EFT. They are also requiring that any previous ERA enrollments complete without EFT will need to be updated to include EFT enrollment. If the EFT enrollment is not completed you will not be able to receive remits via our clearinghouse. Since the payer has chosen Zelis as their only method of ERA enrollment, we unfortunately cannot bypass the EFT enrollment. EDI Enrollment Instructions:

- To authorize Zelis Payments to provide ERA to your clearinghouse, the provider must log onto the Zelis Payments payments portal to complete the enrollment.
- Both ERA and/or EFT enrollment is completed via the Zelis web portal.
- Zelis is a third-party company chosen by payers to manage EFT and ERA transactions. eSolutions, Inc is a HIPAA Trading Partner but is not responsible for the services, website, or any service fees Zelis may charge the provider.
- Enrollment processing timeframe is approximately 15 business days.

• If you don't not have a Zelis Payment Provider Portal account, Call **855-496-1571** between the hours of 8:30AM – 7PM EST Monday – Thursday (8:20AM – 5PM EST Friday) to speak with a Provider Enrollment Advisor

Zelis will ensure that your Tax ID is eligible to enroll then will talk you through data configuration and data delivery options.

They will then send you an enrollment link to set up your portal account and submit an enrollment.

- Scroll to the bottom of the page, then click '**Zelis Provider Payments Portal**' to login.
- Once logged in, click 'PROVIDER SETTINGS.' Choose either 'VRA' and enter your banking information or choose 'Select' for Virtual Credit Cards as your preferred payment method.
- You will be asked to choose your remit delivery method.
 - o Step 1: Choose '835'
 - o Step 2: Choose 'Clearinghouse'
 - o Step 3: Choose 'Practice Insight'
- Once you have selected your Payment and ERA enrollment options, you will have the option to select the notifications you would like to receive.
- Review the information and type Name, Title, Email and check the box indicating you have read the agreement. Click 'Submit.'
